Prairie County Board of Commissioners Todd Devlin, Christine Keltner and Dennis Teske met in regular session at 9:00 a.m. In attendance Commissioner Secretary Harry McNall.

9:06 a.m. Pledge of Allegiance & Call to order. Public comment on agenda matters.

9:29 a.m. Road Supervisor Todd Henry joined the meeting. Updated commissioners on road department projects and roads.

10:00 a.m. Commissioners joined a zoom meeting with Eastern Plans Economic Development Council (EPEDC), Montana Department of Transportation (MDOT), Great West Engineering, Western Federal Highway Administration. Commissioners were updated on the Scour Mitigation and current time frame, with a two-week review from June 13th to June 27th, 2024. And would have a in person meeting and field review on June 26th, 2024. Bid requests for a temporary fix are going out in papers this week and will be opened on May 15th, 2024. There was a discussion of grant requirements for funding of the final bridge project. Next meeting May 29th, 2024, at 2 p.m. via zoom.

11:30 a.m. Meeting with the Hospital CFO Mia Amore Talon over hospital cash control and provided the commissioners with the latest hospital board meeting minutes. The hospital has had issues with US Bank on the county side, and no issues on the hospital side. Separating cash accounts from the county for the hospital to have their own accounts and control over funds had passed a vote through the Hospital Board of Directors. There will still be information exchanged for deposits etc. by the hospital for cash report requirements by statue. County Treasurer Cheryl Morrison explained that it would take 180 days to remove the funds from investments, but if needed quicker it would cost the hospital \$16,000.00 to pay for the fees associated with removing funds out of investment quicker than terms. Cheryl explained to the commissioners how the treasures department will be involved in the hospital reporting process for tax base and accounting.

11:40 a.m. Commissioner Keltner made a motion for "Authorizing Prairie County Hospital District to set up new bank accounts in the hospital's name to be owned and under control of Prairie County Hospital District, with signatories as follows, Chair of Board of Trustees, Board Clerk, and Chief Executive Officers/Administrators of Prairie County Hospital District, with Chief Executive Officer and the Chief Financial Officer to make changes to the accounts and access all account information, the county and hospital will receive and send monthly balancing reports", seconded by Commissioner Teske, open to discussion, "all in favor, All Agree" motion passed.
