Prairie County Board of Commissioners Todd Devlin, Christine Keltner and Dennis Teske met in regular session at 9:00 a.m. In attendance Commissioner Secretary Harry McNall.

9:00 a.m. Pledge of Allegiance & call to order. Public comment on agenda matters. No public comments.

9:10 a.m. County Supervisor Todd Henry joined the meeting. Commissioners discussed with Todd various topics concerning the Cherry Creek Gravel Pit.

on schedule for the full completion of the bridge by December 2025. The quick fix of the bridge will begin July 1<sup>st</sup>, 2024. Next meeting will be June 12<sup>th</sup>,

3:00 p.m. Jamie Larson and David Seitz, with Seitz Insurance to discuss the renewal of workman's compensation insurance. The representatives went over the statistics, the most common claims and overall cost associated with those claims. There is an increase in premiums of \$8,000. Overall, the increase is a direct correlation with claims made from the previous period.

4:31 p.m. Deputy Clerk & Recorder Aria Walters joined the meeting to discuss the advertising of the annual "Meals on Wheels" bidding processing.

4:40 p.m. Commissioners read the minutes from the May 20<sup>th</sup>, 2024, special meeting Quick fix on Milwaukee Bridge.

4:40 p.m. Commissioner Teske made a motion to accept the minutes of the May 20<sup>th</sup>, 2024, special meeting as corrected, seconded by commissioner Keltner, "all in favor" motion passed.
