

## **Prairie County Board of Commissioners Meeting**

May 15<sup>th</sup>, 2024

Prairie County Board of Commissioners Christine Keltner and Dennis Teske met in regular session at 9:00 a.m. In attendance Commissioner Secretary Harry McNall.

9:00 a.m. Pledge of Allegiance & call to order. Public comment on agenda matters. No public comments.

9:00 a.m. Brandon Duffey with Great West Engineering joined the meeting.

9:30 a.m. Milwaukee bridge bid openings by Brandon Duffey. He will post certified bid tabs this week and recommendation to county. The commissioners discussed with Brandon Duffey what options there are for getting this done, and which bidder to choose or consider. The main concern is the timing of starting and completing the project.

5. COP Construction Base Bid \$248,950.00, Alternate 1 \$170,000.00
6. Battle Ridge Builders Base Bid \$278,000.00, Alternate 1 \$187,000.00

1:00 p.m. Compensation Board discussion and recommendation meeting. The Cost of Living Adjustment (COLA) (inflation rate) is 4.1% in 2024. In the past the county has done COLA +1

across the board. The county gave bonuses rather than a raise two years ago, and a raise of .75 cents per hour last year for each employee.

1:35 p.m. Commissioner Devlin made a motion to make 5% increase for pay raises, unless it is not possible then it may be reduced, seconded by Sheriff Lewis, open to discussion, “all in favor” motion passed.

2:25 p.m. Commissioner Devlin Read Resolution 24-24 “Resolution Pursuant of 7-6-4006 of The Montana Code Annotated, Authorizing Amendment of final budget for FY 2023-2024 in Road and Fair Funds.”
