## **RESOLUTION 24-10**

## A RESOLUTION ESTABLISHING PRECINCT BOUNDARIES IN PRAIRIE COUNTY

WHEREAS, 13-3-102, MCA, authorizes the county governing body to change the boundaries of precincts, but not within 100 days before any primary or between a general election and the primary for that election; and

WHEREAS, 13-3-102, MCA, provides that all changes must be certified to the election administrator within 3 days after said change is made; and

WHEREAS, the officials responsible for preparing a districting and apportionment plan shall consider the problems of conforming present precinct boundaries to the new districts as well as existing boundaries of wards, school districts, and other districts; and

WHEREAS, the election administrator of counties involved in the plan must be consulted before adoption of the final plan; and

WHEREAS, the existing Precinct boundary was based on a geographical feature that was subject to change; and

WHEREAS, 13-3-103, MCA, provides that not more than 10 days after an order of the governing body has established or changed the boundaries of an election precinct, the governing body shall ensure that a written legal description and a map showing the borders of all precincts and districts in which elections are held within the county are prepared and delivered to the election administrator.

NOW, THEREFORE BE IT RESOLVED; that a map with the approximate number of electors in each Precinct is attached hereto as Exhibit (A), and the Prairie County Precincts shall be set as follows:

Prairie County shall be divided into two (2) parts by the following boundary:

## **Precinct Line – Prairie County**

Beginning at the NW corner of Section 6, T13N, R52E (Point of Beginning); thence South along the west lines of Section 6 and 7 to the SW corner of Section 7, T13N, R52E; thence East along the south line of said Section 7 to the SE corner of said Section 7; thence South along the west line of Section 17 to the SW corner of said Section 17, T13N, R52E; thence East along the south line of said Section 17 to the SE corner of said Section 17; thence South along the west lines of Sections 21, 28, and 33 to the SW corner of said Section 33, T13N, R52E; thence along the Township line common to said Section 33 and Section 2, T12N, R52E to the NW corner of said Section 2; thence South along the west lines of Section 2, 11, and 14 to the SW corner of Section 14, T12N, R52E; thence East along the south line of said Section 14 to the SE corner of said Section 14; thence South along the west lines of section 24, 25, and 36 to the SW corner of Section 36, T12N, R52E; thence East along the south line of said Section 36 to the SE corner of said Section 36, which is also assumed to be the SW corner of Section 31, T12N, R53E; thence east along the south lines of Sections 31, 32, and 33, which also run along the south Township line of said T12N, to the NW corner of Section 4, T11N, R53E; thence South along the west line of said Section 4 to the SW corner of said Section 4; thence East along the south line of said Section 4 to the SE corner of said Section 4; thence South along the west line of Section 10 to the SW corner of Section 10, T11N. R53E; thence East along the south lines of Sections 10 and 11 to the NW corner of Section 13, T11N, R53E; thence South along the west line of Section 13 to the SW corner of said Section 13; thence East along the south line of said Section 13 to the SE corner of said Section 13, which is assumed to be on the west Range line of T11N, R45E; thence South along said Range line to the SW corner of Section 30, T11N, R54E; thence East along south lines of Sections 30 and 29 to the SW corner of Section 28, T11N, R54E; thence South along the west line of Section 33 to the SW corner of said Section 33, which is also assumed to be the NW corner of Section 4, T10N, R54E; thence south along the west line of said Section 4 to the SW corner of said Section 4; thence East along the south line of said Section 4 to the SW corner of Section 3, T10N, R54E; thence South along the west lines of Sections 10, 15, 22, 27, and 34 to the SW corner of said Section 34, T10N, R54E, said point also being on the Prairie County line: thence following multiple courses in a counterclockwise direction along said Prairie County line to the said Point of Beginning.


- Precinct#1: All that area within the corporate limits of the Town of Terry, Montana, west of the center line of Logan Avenue.
- Precinct #2: All that area within the corporate limits of the Town of Terry, Montana, east of the center line of Logan Avenue.
- Precinct#3: All of Prairie County east of the above described boundary, outside of the Corporate limits of the Town of Terry, Montana.
- Precinct #4: All of Prairie County west of the above described boundary, outside of the Corporate limits of the Town of Terry, Montana.

**BE IT FURTHER RESOLVED** that a public hearing shall be held on the above proposed Precinct Boundaries on the 31<sup>st</sup> day of October, 2023, at 2:30 p.m. in the Prairie County Courthouse The Clerk & Recorder shall cause notice of such hearing to be published in the Terry Tribune, in accordance with §7-1-2121 MCA, at least 2 times with at least 6 days separating each publication.
